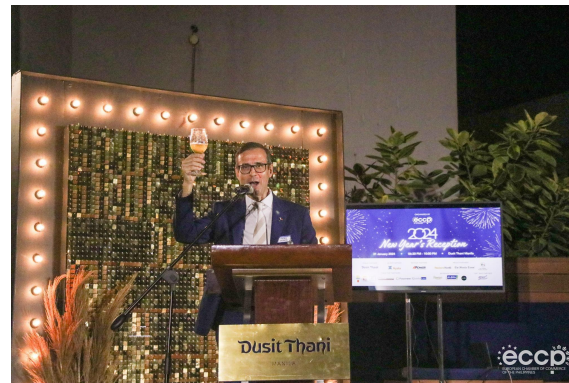
2024 ECCP NEW YEAR'S RECEPTION
